



Restoring our Florida landscape

We have heard from many neighbors about the grounds work being done at the Park and along Shamrock Drive. There are lots of folks who understand what we are doing, but I want to make

sure the whole community understands the activity as we fold the newly acquired ESLPP addition.

Acres of invasive Brazilian Pepper trees along with some Carrotwood trees and other non-natives have been mulched, treated and removed from areas along Shamrock Drive. This removal project is the beginning of a process to restore the landscape to its native habitat. Brazilian Pepper trees were first brought to the United States in the 1890's Before the County purchased these 39 acres, it was desfrom South America - In their native ranges, there are natthem from taking over our native landscapes. so much shade that any vegetation trying to grow underneath is choked out.

These invasives also produce allelopathic chemicals in the soil that make it impossible for anything else to grow nearby. Unattended, eventually, nothing but Brazilian pepper trees would exist, producing a monoculture.

Allowing this to happen in our native habitats, directly affects listed species of wildlife such as gopher tortoises and scrub jays. They destroy mangrove, pineland, scrub, and wetland habitats. In fact, Brazilian pepper trees are so destructive, it is illegal for anyone in the state to grow, harvest, cultivate or transport the tree throughout the state. Since the County purchased this new section of land for preservation purposes, we plan to continually monitor the area to once again re-populate the landscape. The restored habitat will support a much healthier population of Florida wildlife including wading birds, turtles, crabs, raptors and more.

The restoration process will take time, however. We will see many phases of change on our way to the goal.

We are planning to offer you further exciting events for you to enjoy, commencing in the fall.


