Retailing the two-month closure, has severely impacted the retailing industry, and will continue to do so, as people slowly return to a new pattern of behavior in the post Covid 19 world. Many of us have, by necessity, had to go online to view and purchase items. The only issue, given that I was unable to try on a garment, and which I experienced personally, was that the sizing differs quite dramatically, from US sizing to that available in Hong Kong, from whence I ordered some shirts. The shirts were too small and were sent back.

The two month closure, has also significantly increased the use of Amazon, which is growing from strength to strength, and also offers, amazing delivery, of the product, which generally arrives the next day after you ordered, or the day thereafter . We have become reliant, on this quick delivery.

However, I ordered a web camera from Amazon back in mid-February, and learned only a week ago, that the product hadn't even yet shipped from China., Despite being told, by Amazon, when I checked, that it was out for delivery to my home, two weeks ago.

The product was very reasonably priced, and hence was completely out of stock locally, and of course, more expensive web cameras were available in the \$800 and above range but were too expensive for my purposes.

Post Covid 19, we will all continue to rely, on these large multinational companies such as Amazon and Walmart, given the wide range of choice, their pricing, convenience and speed of delivery offered by these giant retailers



## Ahead of the Curve

During the quarantine, we have all learned a new way to live, our new normal. Now connecting with family and friends takes place remotely on video chats or zoom meetings.

ReSound and Phonak have had these smartphone remote programmable hearing aids available for over six months. These companies were ahead of the curve. With social distancing we have noticed a rush to market from the other main manufacturers. So now, we can offer remote programming for certain hearing aid models from Oticon and Widex.
